## Products

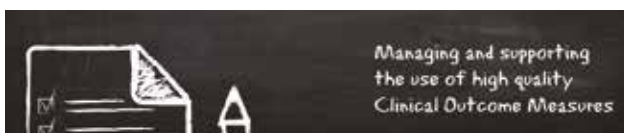

migrated properly, and the all-important measurement properties of the original validated paper version have been retained.

## Example of the Application of our PRO measures

NHS PROMS – In 2009 the routine collection of outcomes following elective surgical interventions was mandated in the NHS for total hip and knee replacement operations. The Oxford Hip and Knee Scores (developed at Oxford and managed by Isis Outcomes) were the condition-specific measures adopted for the national program assessing



almost 200,000 interventions per year in the UK. For the first time the Dept. Health and NHS has evidence of the benefit of this £800M spend in the NHS every year.
